## Nikko Asset Management Publishes its Third TCFD Report

Nikko Asset Management Co., Ltd. (Nikko AM) today published its [third annual report](#) presenting activities aligned with the recommendations of the [Task Force on Climate-Related Financial Disclosures \(TCFD\)](#). The report analyses and presents the impact of climate change on Nikko AM's operating results and financial positions in the 2020 calendar year. Nikko AM's report focuses on the TCFD's recommendations with respect to governance, strategy, risk management, and metrics and targets, and seeks to spotlight the firm's efforts to reflect ESG in its operations as benchmarks for sustainable and responsible investing. The report also explains Nikko AM's efforts to reduce and offset its carbon dioxide emissions across all of its offices worldwide.

As a fiduciary, Nikko AM is dedicated to putting clients' interests first. The firm's fiduciary and environmental, social, and governance (ESG) principles guide its corporate values and actions. The ESG Global Steering Committee assesses and manages the effectiveness of Nikko AM's ESG challenges and initiatives in accordance with the [Principles for Responsible Investment \(PRI\)](#), and ensures that the firm integrates ESG factors in its investment process while remaining engaged with companies that the firm invests in.

Nikko AM committed to TCFD in August 2018, and in May 2019, joined the TCFD Consortium, which is a Japanese initiative that aims to further discussions on effective and efficient corporate disclosure of climate-related information and its use by financial institutions. By updating and disclosing its TCFD report every year, Nikko AM aims to ensure further transparency in its efforts to reflect ESG factors, which are indicators of sustainable and responsible investment, in its investment process. Nikko AM will also work to strengthen and expand its ability to analyse the impact of climate-related risks on the financial condition of companies, and cooperate with stakeholders both within and outside the investment community.
